State	General Sunday Alcohol Sales Hours	Details
Alabama	Varies by county and store type	The state bans beer and liquor sales after 2 a.m., but special permits may be granted. Legislature approval is required for counties wishing to sell alcohol on Sundays.
Alaska	Varies by local jurisdiction	Local governments set rules for Sunday alcohol sales, leading to regional variations. The state allows beer sales for off-premises consumption 24/7, but local jurisdictions may impose their own restrictions.
Arizona	6 a.m. to 2 a.m.	Arizona eliminated its last "blue law" in 2010, allowing alcohol to be sold or consumed every day from 6 a.m. to 2 a.m.
Arkansas	Varies by county	Some counties and municipalities allow Sunday sales, while others prohibit it entirely. Where permitted, sales usually start after 10 a.m.
California	6 a.m. to 2 a.m.	Beer sales are permitted from 6 a.m. to 2 a.m. every day. Some areas may impose limitations for on-premises consumption on Sundays or require customers to purchase food if ordering beer.
Colorado	8 a.m. to midnight	Beer sales are permitted at grocery and liquor stores on Sundays from 8 a.m. to midnight, but businesses may set their own hours within this time frame.
Connecticut	10 a.m. to 6 p.m.	Sunday alcohol sales are limited to these hours whether patrons consume it on-premises or off-premises.
Delaware	Noon to 8 p.m.	Sunday alcohol sales, including beer, are permitted during these hours in most counties. Local regulations may vary.

State	General Sunday Alcohol Sales Hours	Details
Georgia	No alcohol sales before 12:30 p.m.	Sunday beer and alcohol sales are permitted from 12:30 p.m. to 11:30 p.m. in most locations, but local governments may limit or extend their sales hours.
Florida	Varies by county	Sunday alcohol sales laws vary by county. Some allow the sale of beer and hard liquor 24/7, others after 7 a.m. or later, while some restrict Sunday sales entirely.
Hawaii	6 a.m. to 11 p.m.	Beer can be purchased on Sundays from 6 a.m. until 11 p.m., although times may vary by island or county. Bars and restaurants may sell alcoholic beverages from 8 a.m. to 2 a.m. (or until 4 a.m. with a "cabaret license").
Idaho	6 a.m. to 1 a.m.	Some local jurisdictions may have additional restrictions.
Illinois	Noon to midnight	Alcohol sales are generally permitted on Sundays, but local municipalities can set stricter hours. Some businesses may sell beer or liquor outside these hours with the proper license.
Indiana	Noon to 8 p.m.	Some restaurants and bars may sell spirits between 7 a.m. and 3 a.m. for on-premises consumption.
Iowa	8 a.m. to 2 a.m.	Iowa allows alcohol sales, including beer, from 8 a.m. to 2 a.m. on Sundays statewide.
Kansas	Noon to 8 p.m.	Sunday beer sales are permitted from noon to 8 p.m., though some municipalities may have different hours or prohibit sales.
Kentucky	Varies by county	Kentucky has a mix of wet and dry counties, with some allowing Sunday sales and others prohibiting them entirely. Where permitted, sales often start after noon.
Louisiana	Varies by parish	Sunday alcohol sales laws vary widely by parish and business type. Some allow sales all day, and others restrict or prohibit them.

State	General Sunday Alcohol Sales Hours	Details
Maine	5 a.m. to 1 a.m.	Beer and liquor sales are permitted between 5 a.m. and 1 a.m. every day of the week.
Maryland	Varies by county	Sunday beer sales laws vary widely by county, with some allowing sales as early as 6 a.m. Others have strict restrictions or bans. Most counties prohibit the sale of alcohol for off-premises consumption on Sundays.
Massachusetts	10 a.m. to 11 p.m.	Some cities and towns may have additional restrictions.
Michigan	7 a.m. to 2 a.m.	Some local governments may impose additional restrictions.
Minnesota	11 a.m. to 6 p.m.	Minnesota has relatively limited Sunday alcohol sales hours, with sales only allowed from the late morning to early evening.
Mississippi	Varies by local jurisdiction	Mississippi has varied local laws. Most areas permit Sunday beer sales 24/7 for off-premises consumption, while others limit on-premises consumption.
Missouri	6 a.m. to 1:30 a.m.	Missouri allows Sunday beer sales from 6 a.m. to 1:30 a.m. the next day, though local jurisdictions may impose different hours.
Montana	8 a.m. to 2 a.m.	Montana permits the sale of beer and other liquors during this time range.
Nebraska	6 a.m. to 1 a.m.	Sunday beer sales are allowed from 6 a.m. until 1 a.m., though local governments may have certain restrictions for on-premises consumption.
Nevada	24/7	Nevada allows all alcoholic beverages to be sold 24 hours a day, seven days a week.
New Hampshire	6 a.m. to 11:45 p.m.	Sales for on-premises consumption at bars and restaurants can extend until 1 a.m.

New Jersey	Varies by county	Sunday beer sales laws vary by county, with some allowing sales starting at 9 a.m. Others may have restrictions or bans.
New Mexico	7 a.m. to midnight	Some local jurisdictions may have different rules.
New York	10 a.m. to 10 p.m.	Some local jurisdictions may impose additional restrictions.
North Carolina	10 a.m. to 2 a.m.	Restaurants and bars can sell beer and other spirits starting at 10 a.m. Liquor stores and many other alcohol retailers are closed on Sundays.
North Dakota	Noon to 1 a.m.	Restaurants may serve spirits until 2 a.m.
Ohio	Varies by local jurisdiction	Local jurisdictions set their own rules for Sunday alcohol sales. Businesses with a permit to sell beer may do so starting as early as 5:30 a.m. on Sundays and other days of the week.
Oklahoma	Varies by county	Sunday alcohol sales laws vary by county and establishment types. Grocery stores may sell beer between 6 a.m. and 2 a.m., while restaurants and breweries can typically start selling beer between 10 a.m. and noon.
Oregon	7 a.m. to 2:30 a.m.	Sunday beer and alcohol sales for on-premises consumption is permitted from 7 a.m. until 2:30 a.m. Off-premises sales can start at 6 a.m.
Pennsylvania	11 a.m. to 2 a.m.	Businesses with a Sunday Sales Permit can sell beer starting at 11 a.m. (or at 9 a.m. if they also sell food). All beer sales must stop at 2 a.m.
Rhode Island	10 a.m. to 6 p.m.	Rhode Island restricts Sunday alcohol sales to between 10 a.m. and 6 p.m.
South Carolina	Varies by county	Sunday alcohol sales are permitted in some counties, while others prohibit it. Sales typically start after noon where allowed.

State	General Sunday Alcohol Sales Hours	Details
South Dakota	Varies by local jurisdiction	Sunday alcohol sales laws vary by locality. Some areas allow sales starting at 7 a.m., while others restrict or prohibit them.
Tennessee	10 a.m. to 11 p.m.	Sunday beer sales are permitted from 10 a.m. to 11 p.m., though some areas may have restrictions. Bars and restaurants can sell alcohol until 3 a.m. Beer may also be picked up curbside or delivered until 3 a.m.
Texas	10 a.m. to midnight	Retail sales can start at noon and extend until midnight. Bars and restaurants may serve beer or other drinks starting at 10 a.m. if they offer food, but they can't serve alcohol-only guests before noon.
Utah	Varies by establishment	Certain establishments can sell beer on Sundays between 10:30 a.m. and midnight. Some retailers and on-premises providers may have additional restrictions or extended hours.
Vermont	8 a.m. to 2 a.m.	Vermont permits Sunday beer sales from 8 a.m. until 2 a.m.
Virginia	6 a.m. to midnight	Retailers can sell alcohol on Sundays until midnight. Establishments offering food may serve beer and other types of alcohol until 2 a.m.
Washington	6 a.m. to 2 a.m.	Washington allows Sunday alcohol sales from 6 a.m. until 2 a.m.
West Virginia	6 a.m. to 2 a.m.	Customers in most counties can purchase beer every day starting at 6 a.m. Some counties choose to start selling beer later in the day.
Wisconsin	6 a.m. to 9 p.m.	Some municipalities may have stricter rules or bans.
Wyoming	6 a.m. to 2 a.m.	Beer can be purchased from 6 a.m. until 2 a.m. any day of the week, though some localities may impose additional restrictions.
